OFFICE MEMORANDUM

Sub : Re-assignment of work for issue of Consent To Establishment (CTE) and Consent to Operate(CTO) under the provisions of Water(Prevention and Control of Pollution) Act, 1974 and the Air(Prevention and Control of Pollution) Act, 1981 for Infrastructure Projects and Stone Crushers—reg.

The work delegation for issue of Consent for Establishment (CFE) and Consent for Operation(CFO) for Red, Orange and Green category industries at various levels of the Board Officers is issued vide OM cited under ref (1 & 2) respectively.

In compliance to CPCB directions dated 7.3.2016 issued under section 18 (1) (b) of the Water (Prevention and Control of Pollution) Act, 1974 and Air(Prevention and Control of Pollution) Act 1981, Board vide ref (3) has re- classified the industrial sectors based on pollution index, wherein the Stone Crusher sector is now classified under Orange Category and the Infrastructure Projects are classified under Red, Orange and Green categories based on the quantity of waste water generation.

The Consent applications (CTE and CTO) pertaining to Stone Crusher(presently classified under Orange category) and infrastructure activities(irrespective of category) received online through XGN software forwarded from Regional Offices are further processed and disposed at Head Office as per the Office Memorandum cited under reference (4), whereas the disposal of CFE and CFO applications made under Orange and Green Category vests with Zonal Officers and Regional Officers respectively as per Office Memorandum cited under reference (1) & (2).

Meanwhile during the review meeting held on 5.11.2018, Chaired by Chief Secretary to Government, GoK, the issue regarding disposal of consent applications under SAKALA was discussed, it is directed to comply with the SAKALA time lines and dispose the consent applications within the time lines.

Keeping in view of the above, after detailed deliberation in State Level Consent Committee Meeting, it was decided that the consent applications pertaining to infrastructure projects which are categorized under Orange & Green and Stone Crusher projects which are categorized as Orange category shall henceforth be disposed at Zonal Senior Environmental Officer's and Regional Officer's as per the delegation of powers given below.

Hence, in order to bring compatibility with XGN software and to dispose the CTE and CTO applications effectively within the stipulated SAKALA timelines, and also to manage the Consent to Establishment (CTE) and Consent to Operate (CTO) applications pertaining to Stone Crusher and Infrastructure Projects, order issued vide Office Memorandum cited under ref (1) & (2) regarding re-assignment of duties for issue of Consent To Establishment (CTE) and Consent to Operate (CTO) under the provisions of Water(Prevention and Control of Pollution) Act, 1974 and the Air(Prevention and Control of Pollution) Act, 1981 is partially modified as below :

The Consent applications filed under provisions of Water (Prevention & Control of Pollution Act) Act, 1974, Air (Prevention & Control of Pollution) Act, 1981 shall be disposed as indicated below:
