Preamble: Industries and Construction projects covered under Environmental Impact Assessment Notifications, 2006 and amendments thereafter are taking both Environmental Clearances from concerned authority viz., S.E.I.A.A Karnataka and MoEF & CC, Gov. of India depending on category of project as well as Consent for Establishment from Karnataka State Pollution Control Board. It is noted that, Project Proponents are splitting the activity and taking part CFE's from the Board. This creates duplication of work to Board and also not in accordance with law and as well EODB. This practice of taking part CFE's needs to be discouraged and the project proponents have to be directed to apply for single CFE in line with the EC permitted quantities, however, they may take partial CFO's depending on completion of the project.

Further, Board had already signed one O.M dated: 26.07.2022 clarifying the procedure to be followed in case of CFE and CFO renewals attracting EIA Notification, 2006. There is no change in the same.

In view of the above, all the officers of the Board are informed to follow the above direction while accepting and disposing Consent for Establishment applications attracting EIA Notification, 2006 and amendments thereof.
